- 1. The Meeting of the BSEC Working Group on Exchange of Statistical Data and Economic Information was held online, on 21 May 2025.

- 8. Under this Agenda Item, the representative from the Secretariat provided information on the steps already done and/or to be done for the preparation of the report of the Secretary General on the implementation of the BSEC Economic Agenda as decided by the Council of Ministers of Foreign Affairs of the Member States at its Meeting held on 28 June 2024, namely:
  - (1) the Working Group is meeting regularly;
  - (2) regular and efficient exchange of data, expertise and experiences among the Member States;
  - (3) resuming of the publication of the Compilation of Main Economic and Social Indicators for the BSEC Countries;
  - (4) reactivation and strengthening of the work of the existing Coordination Center for the Exchange of Statistical Data and Economic Information, as an Affiliated Center of BSEC.
- 9. The representatives of the Republic of Türkiye presented national activities and best practices in the field of statistics, and progress achieved in the implementation of the Goal 13 of the BSEC Economic Agenda, such as the statistical website for children, the publication of statistics on the occasion of the 100th Anniversary of the Republic of Türkiye, the preparation for an exibition next year for the 100th Anniversary of TurkStat, etc.

## AGENDA ITEM 3: DISCUSSIONS OF THE DRAFT COMPILATION OF MAIN ECONOMIC AND SOCIAL INDICATORS FOR THE BSEC COUNTRIES

- 10. The representative of the BSEC Coordination Centre on Exchange of Statistical Data and Economic Information (as well as the Country-Coordinator of the Working Group) presented the updated Aggregated Table prepared with the contributions sent so far from the Member States and their recent updates and presented some missing data and data that need to be checked.
