- 16. The delegation of the Republic of Serbia provided information on the lessons learnt and experience of the country regarding the consequences of the COVID-19 pandemic.

17. The Working Group expressed its condolences to the delegation of the Republic of Serbia over the decease of Mr. Predrag MARIC, Head of the Sector for Emergency Management of the Ministry of Interior of the Republic of Serbia.

## AGENDA ITEM 6: EXCHANGE OF VIEWS ON MECHANISMS FOR REGIONAL COOPERATION IN EMERGENCY SITUATIONS

- 18. The participants exchanged views on establishment of possible effective mechanisms for regional cooperation in emergency situations.
- 19. The delegation of Romania reiterated the idea of using the BSEC Network of Liaison Officers on Emergency Assistance as an effective tool for regional cooperation, and urged the Member States to periodically update the contact details of liaison officers, in order to ensure the possibility of immediate action in case of emergency situation.
- 20. The delegation of Romania invited the BSEC Member States to update information in the Unified Database including the contact details of the Liaison Officers of the BSEC Network on Emergency Assistance by the next meeting of the Working Group. The PERMIS will provide them with the necessary details on the access to the Database.
- 21. The Working Group took note of the request of the Observers for having the access to the Unified Database.
- 22. The delegation of the Republic of Armenia proposed to convene a Joint Meeting of the Working Group on Cooperation in Emergency Assistance and the BSEC Network of Liaison Officers on Emergency Assistance.

## AGENDA ITEM 7: THE OUTCOME OF THE ONLINE MEETING OF THE BSEC AD HOC WORKING GROUP OF EXPERTS IN SEISMIC RISK (9 June, 2021)
