30 November 2023, online

- 1. The Meeting of the BSEC Working Group on Energy was held online on 30 November 2023.
- 2. The Meeting was chaired by Mr. Elnur ALAKBAROV, Head of Division for Affairs with International Organizations, Ministry of Energy of the Republic of Azerbaijan.
- 3. The Meeting was co-chaired by Ms. Halime SEMERCI KUŞÇU, Head of the Department of Multilateral Affairs and the European Union, Ministry of Energy and Natural Resources of the Republic of Türkiye, in the capacity of the Chairmanship-in-Office.

- 18. The delegation of the Russian Federation stressed the necessity to follow the principle of balanced representation of the events of the BSEC-GEN and called the host countries to stick to their international obligations in order to maintain it.

- 21. Professor MAVRAKIS announced that the 11th Green Energy Investments Forum is scheduled to take place in Athens in October 2024.
